Engagement of Programme Management Unit (PMU)

for Implementation of Renewable Energy Schemes/Programmes

Solar Energy Corporation of India Limited (SECI), on behalf of the Ministry of New and Renewable Energy (MNRE), intends to engage a professional agency for establishing a dedicated Programme Management Unit (PMU) to provide programme management, implementation, technical, financial, IT, State/DISCOM coordination, communication and community/beneficiary engagement support for various renewable energy schemes/programmes from time to time.

- Community and beneficiary engagement;
- Programme monitoring, reporting and analytics;
- Qualifications and experience of proposed resources;
- Deliverables, KPIs and performance requirements;
- Deployment and resource management;
- Coordination mechanism with MNRE, SECI and other stakeholders;
- Any other aspect considered relevant for effective functioning of the PMU.

The proposed PMU is intended to function as a scheme-agnostic support unit and may be required to support existing as well as new renewable energy schemes/programme undertaken by / assigned to SECI from time to time.
